**SCHEDULE YL
AUTOMATIC YARD LIGHT SERVICE**

AVAILABILITY

Available to all consumers for all private uses subject to the established rules and regulations of the Cooperative.

TYPE OF SERVICE

120 volt light mounted on an existing Cooperative pole. The member will be responsible for any additional charges to locate light away from the Cooperative's existing facilities. Should the light fail, it is the responsibility of the consumer to notify Wild Rice Electric Cooperative. Light will be repaired when service crew is in the area.

RATE

CHARGES PER LIGHT

Yard Lights (monthly) \$8.75

OTHER CHARGES

The consumer shall be responsible for the reasonable care of the light, including repair of vandalism, damage or breakage.

Moving or reinstalling of an existing light will be on a time and material basis with a minimum charge of \$50.00.

TERMS OF PAYMENT

The above rates are net, and should the payment of charges due not be made, the light is to be disconnected and then retired.

TAXES

State Sales Tax applicable to the sale of electricity shall be added to the amount of each monthly bill as required by law.

YARD LIGHT AGREEMENT

I _____ (Member) agree to purchase from Wild Rice Electric Cooperative, Inc. (Cooperative) a yard light service located at _____ .
The yard light will not be metered and I agree to pay the Cooperative a monthly charge per light under the terms and conditions of Schedule YL of Wild Rice Electric's rate schedule. Failure to make said monthly payment will be cause for disconnection or removal of the light.

The **LED light** will be mounted on an existing Cooperative pole. I understand that a request for any additional service beyond installation of the light on the Cooperative's existing pole will be my responsibility and I will be charged for any such additional costs.

The Cooperative will be responsible for normal maintenance of the yard light. I understand that it is my responsibility to notify the Cooperative if the said yard light is not properly operating. I also understand that I shall be responsible for the reasonable care of the light, including repair of vandalism, damage or breakage.

Moving or reinstalling of an existing light will be on a time and material basis with a minimum charge of \$50.00. Posts, fixtures or additional equipment, not part of a standard yard light package, will be paid for or provided by the consumer.

Installation and/or repair of a yard light will be completed during normal working hours of the Cooperative and within a reasonable time period when service crews are in the area.

I have been made aware that yard lights often do not perform well in extremely cold weather conditions so I will not hold the Cooperative responsible for operation of the light during such periods.

I understand and agree to allow the Cooperative to enter my property to install, repair, and maintain the said yard light. I also agree to hold the Cooperative harmless for any liability that may result from the light not operating properly.
